The program Beach Clean, whose partners include the Topsail Island Shoreline Protection Commission, Pender County, and Onslow County, has been recognized with an Achievement Award from the National Association of Counties (NACo). The award honors innovative, effective county government programs that strengthen services for residents.

Spotlight on Blue Flag USA beach sites

B lue Flag USA awarded sites host at least five educational activities a year for their communities. These creative events can be passive campaigns like participation in the annual Earth Hour held each spring, or activities such as trash collection in parking lots or roadways adjacent to the sites, and discussing opportunities to reduce sources of waste entering the environment. Here are a few activities



our sites have offered this season:

Delray Beach, FL, offered a Bio-Biitz for participants of all ages focused on the importance of dune

diversity and teaching participants the specific plants and wildlife that call the Delray's dunes home. Coastal plants prevent beach erosion, capture sand, provide habitat and food for wildlife and birds and butterflies, and are aesthetically pleasing for beach goers. This guided tour of unique plants also utilized the iNaturalist app.

The Westward Beach, CA, information board publicizes the Ocean Heroes Activity Guide. The guide promotes positive environmental behaviors for children both at the beach and at home and focuses on the importance of water, actions to protect the environment, and how watersheds influence trash at the beach and how they get involved. From games to seaweed jokes, the Ocean Heroes guide engages children to look at the world around them through an environmental lens.
